

LPOA Pontoon Boat Rental Rules

1. **Rental Period**
 - Boats may be rented between the hours of 8:00 a.m. & 10:00 p.m.
 - Minimum of 2-hours Monday through Thursday
 - Minimum of 4-hours Friday through Sunday
2. **Reservation through LPOA administrative offices is required**
 - Reservations can be made Monday – Friday through the LPOA administration office by calling 373-4326 at anytime during normal office hours (8:30 a.m. – 5:00 p.m.)
 - Saturday & Sunday rental arrangements can be made through the LPOA Patrol by calling 373-1500 **before 10:00 a.m.** on those days.
 - Boat reservations may not be reserved more than a month in advance. For example, to rent the boat for the 15th of the month (ex. June 15th) you can reserve the boat no sooner than the 15th of the prior month, regardless of the number of days in the month.
 - Same day rental must be made before 12:00 P.M. on weekdays.
3. **Cancellations**
 - **Cancellations must be made prior to 48 hours of the reserved time or member's account will be charged for the contracted amount of rental.**
4. **Rental Contract**
 - Contract must be signed by Lakewood property Owner (no rentals will be made to dependents) in order for pontoon to be considered reserved.
 - Proper identification will be required at the time of rental with a valid Lakewood ID card.
 - Only LPOA members who are in good standing may submit a contract for rental of the pontoon boat.
5. **Rental Fees and Payment of Fees**
 - Monday-Thursday (excluding holidays) \$28.50 per hour
 - Friday-Sunday \$50.50 per hour
 - All Day Rental (excludes Fri-Sun & holidays) \$194.00
 - Holidays \$62.00 per hour
 - Damage Deposit \$250.00. From this deposit, any damages to boat and any late fees will be deducted. The remainder will be credited back to the member's account, if applicable.
 - All rental fees, damages, and late return fees will be charged to the LPOA member's account.
6. **Damages to Boat**
 - If damage has occurred to the pontoon boat, the member will be responsible for repair/replacement of the item. The amount will be charged to the member's account.
7. **Late Returns**
 - Late returns will be charged at the rate of \$15.00 per each 15- minute period the boat is late being returned. Amount to be charged to member's account (i.e. 1-15 minutes = \$15.00, 16-30 minutes = \$30.00, 31-45 minutes = \$45.00, 46-60 minutes = \$60.00 and etc.)
8. **Pick-up and Return of Pontoon Boat**
 - **Boat is to be picked up and brought back to the pleasure dock located at the East Lake Marina (just north of the boat ramp)**
 - **Individuals who require an accommodation should contact our offices at least 48 hours in advance**
9. **Equipment**
 - LPOA to furnish life jackets (10 adults & 2 children) and gas.
10. **Pontoon Boat Occupancy**
 - 10 people or 1,370 LBS
11. **Rain Checks**
 - **Rain checks will be given for inclement weather (rain, thunder, lightening). All other periods will be charged at the normal rate under which the reservation was submitted.**
