#### Silent Generation (1925 to 1946)

This generation experienced significant historical events such as World War II and the Great Depression, which shaped their values and work ethic. They are often characterized

- Loyalty: Strong sense of loyalty to their employers and institutions.
- Discipline: High regard for discipline and respect for authority.
- Frugality: Conservative approach to spending and saving, influenced by the economic hardships they faced.

#### Baby Boomers (Born 1946-1964)

Baby Boomers were born during the post-World War II baby boom, a period of significant population growth. This generation is known for its:

- Work-Centric Attitude: Strong work ethic and dedication to their careers.

# **Lake Irrigation Fees**

Residents who irrigate from the lake should expect to receive their bill in October in the amount of \$206.50. The fee is not for use of lake water, but rather for access to the lake water. Access means you have an irrigation pump and intake lines installed. If you have one or both of these items, you are required to pay the irrigation fee. If you choose to not pay for the fee, you will need to remove the pump and/or intake lines before December 31, 2024 and notify the LPOA office by calling 816-373-4326.


# **Political Signage**

## ENVISION LAKEWOOD

#### PLANNING TODAY FOR TOMORROW

In December of 2023, the Board approved the creation of a Vision Steering Committee to create a *Strategic Plan* for our community. A critical component of creating a plan is data and input from residents. In August, we contracted with **Shockey Consulting** to assist us with this process.

After multiple meetings and a planning session, we have named this exciting new project that will ultimately lead to the creation of a strategic plan designed to shape the future of our community:

"ENVISION Lakewood – Planning Today for Tomorrow"

As part of the *ENVISION* campaign, we're excited to announce that the first in a series of *community engagement surveys* is now available. Don't miss out! We're excited to hear your thoughts.

## Community FAQ ...

#### Where do I access the survey?

The survey is available to you several ways:

- The survey link will be emailed to residents, who have an email address on file, on **Tuesday, October** 1st. (we request only one response per household)
- The survey link will be available in the weekly Monday Eblasts.
- · You can access the "link" provided in this issue of the Ripples or scan the "QR code" provided.
- · The survey link will be located on the LPOA Website.
- You may obtain a paper copy at the office. You will need to return the completed survey to the office.
   The survey will remain confidential and submitted to Shockey.

#### Why should I complete the survey?

The surveys are your chance to share what you value about our community. Your input is important to ensure that we capture the needs and desires of all residents. "YOUR FEEDBACK, OUR FUTURE – JOIN THE CONVERSATION"

#### Why is personal information being asked?

The demographic information requested in the survey will allow us to establish a comprehensive baseline of our residents, ensuring that the strategic plan reflects the diverse needs and perspectives of the entire community. By conducting additional surveys every five years, the association will be able to track the demographic changes within the community, ensuring that plans remain relevant and responsive to evolving needs.

#### Will I see the survey responses?

A summary of the survey responses will be added to the website, but individual submissions will remain confidential.

#### What's a Strategic Plan?

A strategic plan is a community roadmap for the next 5-10 years. The plan will outline major areas of focus for improvement, measurable goals, and potential actions to be taken that will help reach those goals. It will be informed by the community's mission, vision, and values.

#### What questions will this plan answer?

The final plan will provide community leaders and staff with answers to questions like:

- · What are our greatest areas for improvement?
- How do we best utilize our limited time and resources?
- What do residents want to see from their community?
- What values and goals should we be prioritizing when making tough decisions?

#### What's the timeline?

Initial planning for the process began in the Spring of 2024. The final plan will be completed in the Spring of 2025 and will provide a roadmap for the next 5-10 years.

#### How can I engage?

During this process, residents will be sent a series of questionnaires that are vital to the production of the final plan. Community members were also selected through application to form a Steering Committee, which will engage in multiple workshops throughout the process.






