Golf Carts traffic will be restricted to "Cart Path Only" from November 1 to March 1.

All golfers know what "Cart Path Only" means. However, most golfers do not adhere to the one major point of "Cart Path Only":

All 4 tires should remain on the cart path at all points during your round

While some members try to make room for other carts to pass, they most likely are only pulling 2 tires off the path and damaging turf (especially around tees and greens). To make matters worse, the other cart has to pull their other two tires off path on the other side to try and bounce around.

Mud on our tires after a cart path only round is an obvious sign that you have not been keeping all 4 tires on the path and or leap frogging other carts throughout your round. Please do your best to follow the "Cart Path Only" restriction for the off-season.




